# **2022 Bendigo and Adelaide Bank Scholarship for regional** and rural students

The Scholarship program) aims to assist outstanding but disadvantaged students from a rural or regional area, who have been offered a full-time place at an Australian university or college for the first time in 2022.

The Scholarship program supports the following study related expenses - accommodation costs, course costs, study-related materials/equipment, textbooks, tutoring and /or education related travel (within Australia).

The Scholarship award value is \$5,000 per year for two years for each successful recipient, subject to the criteria set out below and satisfactory academic performance in the first year of study.

# Key qualification criteria:

- You are an Australian citizen or permanent resident from a rural or regional location;
- You will be a first-time, first year undergraduate in 2022 this is your first attendance at university/college;
- You will be studying on campus for a full-time bachelor's degree in an approved Australian course at an Australian university or college campus;
- You graduated from secondary school in either 2021 or in 2020 (you took a gap year);
- You can demonstrate the disadvantage (economic &/or social) hindering your ability to undertake tertiary education; and
- You can demonstrate outstanding academic achievement and extensive community involvement.

#### **On-farm Emergency Water Infrastructure Rebate Scheme**

South Australian primary producers in drought affected areas can now apply for a new funding round of the On-farm Emergency Water Infrastructure Rebate Scheme.

You may be eligible for a rebate of 25% (maximum \$25,000 ex GST) for the cost of purchasing and installing new on-farm water infrastructure for livestock and permanent horticulture that:

- addresses animal welfare needs during periods of drought
- assists primary producers to be more resilient for future droughts by protecting permanent horticulture assets.

#### Funding is available for applicants who:

- have completed eligible water infrastructure activities
- are planning to undertake water infrastructure activities (including pl acing orders)
- can provide evidence of their completed or proposed activities
- meet the eligibility criteria outlined in the guidelines.

If you have completed your project, you should submit your application, including provision of supporting evidence.

# Soil Science Challenge

The Soil Science Challenge is part of the Australian Government's commitment to a \$214.9 million National Soil Package to implement the National Soil Strategy. The National Soil Strategy sets out how Australia will value, manage and improve its soil for the next 20 years. The strategy prioritises soil health, empowers soil innovation and stewards, and strengthens soil knowledge and capability.

Applications are being accepted for up to \$5 million total funding over 4 years for the Soil Science Challenge.

# **Storm Recovery Grant**

Disaster recovery grants of up to \$10,000 are available to eligible South Australian primary producers who suffered direct storm damage in the 2021 spring storms.

Grants are to help pay for the costs of clean-up and other emergency measures including rebuilding or replacing damaged or destroyed on-farm infrastructure, to assist the immediate recovery of primary production enterprises.

The maximum grant available for clean-up and reinstatement activities is \$10,000 per primary production business. Assistance is being provided through the jointly funded Commonwealth-State Disaster Recovery Funding Arrangements (DRFA).

Make sure you read and understand the grant guidelines – they explain who is eligible to apply, and what storm recovery activities can and cannot be paid for with grant money. You must have completed the 2021 SA Statewide Storms online survey to be eligible for a grant.

# Thyne Reid Foundation Playford Trust - PhD Scholarships

The Playford Trust in partnership with the Thyne Reid Foundation offers three PhD scholarships intended to supplement an existing Australian Government Research Training Program Stipend Scholarship (RTPS) or similar institutional PhD stipend scholarship.

Students must be undertaking their research with The University of Adelaide, Flinders University or the University of South Australia in the following priority areas for the Trust:

- agriculture and food production
- environmental sciences including water, energy and climate change
- advanced manufacturing and new technologies
- health sciences and enabling technologies
- mining and resources development.

Each scholarship is valued at \$24,500 and is paid at the rate of \$7,000 per annum for three and a half years. The Trust will accept an application for an extension of time, subject to satisfactory progress and appropriate support from the university and the PhD supervisor. However, approval of an extension is not automatic.

#### **Arts Sustainability Fund**

The Arts Sustainability Fund supports the arts and entertainment sector to continue its activities by providing necessary finance to plan a pathway for recovery from the effects of COVID-19. Funding will support employment and contribute to rebuilding Australia's economy, as well as enhancing community wellbeing and access to cultural experiences across Australia.

The Arts Sustainability Fund will provide \$50 million over two years in 2020–22 so that significant Commonwealth-funded performing arts and culture organisations remain solvent, provide employment, and deliver high-quality cultural and creative activities and experiences for audiences.

Applications close 31 May 2022 or until all funds are allocated, whichever is sooner.

#### AgTech adoption rebate for livestock producers

As part of the Government of South Australia's \$7.5 million Red Meat and Wool Growth Program, the Livestock Agtech Adoption Rebate will provide livestock producers with a rebate to help adopt technology, enabling productivity and efficiency gains in their enterprises.

To be eligible for the Rebate, producers need to have participated in a Livestock Enterprise Planning session, leading to the development of a 'Farm AgTech Adoption Plan'.

# Amount of funding available:

You can access a rebate of up to \$10,000 (excluding GST) to use towards implementing priorities identified in your Adoption Plan.

# The rebate can contribute to:

- 75% of costs associated with training, consultancy and/or advisory services up to a total rebate amount of \$2,500 (excluding GST)
- 50% of costs for eligible precision livestock management technology up to a total rebate amount of \$7,500 (excluding GST), of which up to \$2,500 (excluding GST) can be used to pay for pregnancy scanning of ewes.

# **Saluting Their Service Commemorative Grants Program**

The program is designed to preserve Australia's wartime heritage; involve people around the country in a wide range of projects and activities that highlight the service and sacrifice of Australia's service personnel in wars, conflicts and peace operations, understanding of the experiences of service and the roles that those who served have played in shaping the nation.

There are 2 categories of grants available under the program:

- 1. **Community Grants**: maximum of \$10,000 are available for local, community-based projects and activities.
- 2. Major Grants: between \$10,001 and \$150,000 are available for major commemorative projects

# **Boosting Apprenticeships**

The Boosting Apprenticeship Commencements wage subsidy supports businesses and group training organisations to take on new apprentices and trainees, to build a pipeline of skilled workers to support sustained economic recovery.

Through the subsidy, any business or group training organisation that engages an Australian Apprentice between **5 October 2020 and 31 March 2022 may be eligible** for a subsidy of 50 per cent of wages paid to a new or recommencing apprentice or trainee for a 12-month period from the date of commencement to a maximum of \$7,000 per quarter. There is no cap on the number of eligible trainees/apprentices.

# **Strengthening Rural Communities – Round 12**

The Strengthening Rural Communities (SRC) program aims to give the thousands of small rural, regional and remote communities across Australia an opportunity to access funding to support broad community needs. South Australia has General Support grants of – \$6,500 and Bushfire Recovery grants up to \$25,000 in eligible local government areas which are available through the Bushfire Recovery Stream.

Projects funded must align with one or more of the following charitable outcomes:

- bringing people and community organisations together to foster stronger, more resilient communities
- fostering and celebrating a sense of identity, diversity and cultural connection within the community
- improving community health and social wellbeing
- enable people to develop skills, knowledge and confidence to lead and contribute to their community
- enhancing places where communities gather
- rural, regional and remote communities endeavouring to reduce the impacts of the changing climate within their community.

# **Horticulture Netting Infrastructure**

\$14.6 million in grants for South Australian horticulture growers to purchase and install protective netting has been made available. You can apply for up to 50% of costs associated with horticulture netting, up to a maximum of \$300,000.

#### Who can apply?

- primary production businesses
- property owners and share farmers
- lease holders and businesses that operate as a sole trader
- partnership, trust or private company in horticulture.

#### Grant Programs include:

- Tourism, hospitality and gym grant (turnover based payment): \$3,000 for employing businesses or \$1,000 for non-employing businesses.
- Business hardship grant: \$6,000 for employing businesses or \$2,000 for non-employing businesses
- Major events grant: Up to \$100,000 for organisers of cancelled or postponed major public events

# **Wine Tourism and Cellar Door Grant**

The Wine Tourism and Cellar Door Grant program (the program) has been introduced to support producers who add value by encouraging visitors to wine regions. Wine producers will be able to access an annual grant reflective of their eligible physical cellar door sales. Total amount available is \$10,000,000.

To be eligible for the Wine Tourism and Cellar Door Grant applicants must:

- be a wine producer
- be a legal entity registered for GST and with an active ABN
- have owned or leased a physical cellar door in Australia in the relevant financial year, and/or their related entities have owned or leased a physical cellar door in Australia in the relevant financial year
- have a liquor licence valid in the relevant financial year

# Assistance for businesses employing young people – YOUTH JOBS PaTH

Youth Jobs PaTH (Prepare – Trial – Hire) provides funding to trial a young person aged between 17 - 24 to find out if they're the right fit for your business. If the trial is a success and you hire the young person, you may be eligible for further funding. Grant funding available of up to \$10,000 for Australian businesses.

- **Prepare:** Young people will undertake Employability Skills Training to prepare them for work
- **Trial:** You can trial a young person in an internship for between 4 and 12 weeks and receive a payment of \$1000 (GST inclusive) to help cover the hosting costs. Interns will receive a \$200 fortnightly incentive payment on top of their income support and are covered by insurance, both paid by the Australian Government
- **Hire:** If you hire the eligible young person, you can receive a wage subsidy of up to \$10,000 (GST inclusive)

#### **CSIRO Kick-Start**

The CSIRO Kick-Start provides matched funding for start-ups and small to medium enterprises to help access CSIRO's research expertise and capabilities to help grow your business with commercial potential.

Funding may be used to cover the costs of undertaking the project, and may include:

#### **Nature-based Tourism Co-investment Fund**

# **Department for Infrastructure and Transport - Boat Launching Facilities**

An applicant applying for funding to assist with the construction of new boating facilities must commit to the on-going ownership and maintenance of the facility.

Eligible Boating Projects are either the establishment of new or the upgrade of existing facilities and may include a boat ramp, a wharf or pontoons.

# **Youngcare's Home Support Grants**

The Youngcare Home Support Grants are available for individuals aged between 16 and 65 who have a physical disability and who need essential funding to either remain living at home or move back home from inappropriate housing such as Aged Care.


The Youngcare Home Support Grant provides up to \$10,000 (\$20,000 in extreme situations) for essential equipment, home modifications and services, and household items and utilities.

Youngcare's Home Support Grant can provide funding where there are critical gaps in an NDIS participant's plan, but there is still clear evidence of need. The grant also seeks to bridge the gap in essential services and support for families in need, during the transitional period while they gain access to the NDIS.

# The Norman Wettenhall Foundation – Small Environmental Grant Scheme

The Small Environmental Grant Scheme will provide support for people undertaking projects that will make a positive difference to the natural living environment, in land, sea or air, rural or urban. You submit an Expression of Interest (EOI) and if it is accepted, then you'll be supplied with a closing date for submitting your full application - make sure to get your EOI submitted as close to the opening date as possible.

There are opening dates for these grant rounds – this is when the online application form appears 'live' on the website.

#### **HomeStart First Home Grant**

Build your first home from \$3,000. Instead of buying a block of land and then finding a builder to build your home, a house and land package bundles it all together. This means you can choose one of many standard or customised home designs at the same time you purchase the land.

House and Land Packages can be a good way to reduce upfront costs because:

- You only pay stamp duty on the land value and not the house
- HomeStart can lend up to 97% of the value of the house and land package to those who are eligible.
- First home buyers could also be eligible for a \$15,000 First Home Owner Grant to put towards your deposit, fees and charges
- Pay no loan repayments for 9 months or until your home is built, whichever comes first
- Our participating builders will commit to a fixed price and construction period
- HomeStart doesn't charge a Lender's Mortgage Insurance (LMI) and the Loan Provision Charge (LPC)
  is significantly less than LMI for most borrowers

#### The Retailer Energy Efficiency Scheme (REES)

South Australian households and businesses may be able to access discounted or free energy efficiency activities from energy retailers participating in the REES. Low-income households may also be able to receive an energy audit. The Minister has set the approved REES energy efficiency activities; however, each energy retailer participating in the scheme decides on what mix of those energy efficiency activities it will undertake to meet its targets.

To find out what activities energy retailers are currently offering, you can contact any of the obliged energy retailers in South Australia, not just the retailer currently supplying you. Energy retailers may contract out their energy audits and energy efficiency activities to third-party contractors, and you may also contact these third-party contractors directly.
