#### **Regional Event Fund:**

The Regional Event Fund is designed to strengthen the state's regional events calendar and drive economic stimulus across the regions beyond the traditionally peak summer tourism period. The South Australian Government recognises the huge impact that COVID-19 has had on the events sector in South Australia.

The Regional Event Fund aims to:

- strengthen the regional events calendar
- drive regional visitation in the immediate term and lead to repeat visitation
- increase event specific visitor expenditure, particularly from interstate
- assist in COVID-19 recovery recognising that events provide a vibrant and positive social environment for communities
- promote a year-round calendar of regional events
- encourage sustainable event opportunities to build long term capability
- increase collaboration and partnerships among regional event stakeholders, government and commercial partners to deliver stronger outcomes for regional events.

There are four categories in the Regional Event Fund:

- Significant Event Funding
- Established Event Funding
- Development Event Funding
- Emerging Event Funding

#### Strengthening Rural Communities - Round 13

The Strengthening Rural Communities (SRC) program aims to give the thousands of small rural, regional and remote communities across Australia an opportunity to access funding to support broad community needs. Grants are available for a broad range of grassroots, community-led initiatives that directly and clearly benefit local communities.

Grants up to \$10,000 are available through the Small & Vital Stream and grants up to \$25,000 are available through the Bushfire Recovery Stream.

Projects funded must align with one or more of the following charitable outcomes:

- bringing people and community organisations together to foster stronger, more resilient communities
- fostering and celebrating a sense of identity, diversity and cultural connection within the community
- · improving community health and social wellbeing
- enable people to develop skills, knowledge and confidence to lead and contribute to their community
- enhancing places where communities gather
- rural, regional and remote communities endeavouring to reduce the impacts of the changing climate within their community.

#### Partnerships Program - Registration of Interest

#### **City-Country Partnerships**

#### Regional Arts Fund - Project Grant

Individuals can apply for Project Grants of up to \$30,000 for a project starting from 1 July 2022 - there is no minimum grant amount. Project Grants will fund high-quality arts projects benefiting regional or remote artists, art workers, audiences, and communities. The focus of the project could include any area of creative practise, multiple artforms or cross-disciplinary practise.

#### Who can apply?

To be eligible you must:

- be an individual or Australian incorporated organisation or local government organisation
- have an active Australian Business Number (ABN) registered to your name and location
- be registered for the purposes of GST if required by the Australian Tax Office
- not have any outstanding reports, acquittals or serious breaches relating to any Australian Government funding.

#### **Business Hardship Grant - February 2022**

The South Australian Government has introduced a further support package for businesses and organisations impacted by the health restrictions that have been in place since 27 December 2021. The grants in this support package are in addition to both rounds of the Tourism, Hospitality and Gym Grant and Business Hardship Grant that were announced in December 2021 and January 2022.

The Business Hardship Grant provides a grant of up to \$11,000 for South Australian businesses that experience a 50% or more decline in turnover in the month of February 2022 compared to an equivalent reference period, due to the impact of COVID-19.

#### On-farm Emergency Water Infrastructure Rebate Scheme

South Australian primary producers in drought affected areas can now apply for a new funding round of the On-farm Emergency Water Infrastructure Rebate Scheme.

You may be eligible for a rebate of 25% (maximum \$25,000 ex GST) for the cost of purchasing and installing new on-farm water infrastructure for livestock and permanent horticulture that:

- addresses animal welfare needs during periods of drought
- assists primary producers to be more resilient for future droughts by protecting permanent horticulture assets.

#### Funding is available for applicants who:

- have completed eligible water infrastructure activities
- are planning to undertake water infrastructure activities (including pl acing orders)
- can provide evidence of their completed or proposed activities
- meet the eligibility criteria outlined in the guidelines.

If you have completed your project, you should submit your application, including provision of supporting evidence.

Applications close on 30 June 2022 at 5:00pm or when funding for the round is exhausted, whichever comes first.

#### **Storm Recovery Grant**

Disaster recovery grants of up to \$10,000 are available to eligible South Australian primary producers who suffered direct storm damage in the 2021 spring storms.

Grants are to help pay for the costs of clean-up and other emergency measures including rebuilding or replacing damaged or destroyed on-farm infrastructure, to assist the immediate recovery of primary production enterprises.

The maximum grant available for clean-up and reinstatement activities is \$10,000 per primary production business. Assistance is being provided through the jointly funded Commonwealth-State Disaster Recovery Funding Arrangements (DRFA).

Make sure you read and understand the grant guidelines – they explain who is eligible to apply, and what storm recovery activities can and cannot be paid for with grant money. You must have completed the 2021 SA Statewide Storms online survey to be eligible for a grant.

#### **Major Events Support Grant**

A Major Events Support Grant of up to \$25,000 is available for the operators of major one-off events impacted by the health-related trading restrictions. These include major public events in South Australia, organisations will need to provide proof of non-recoverable financial loss - this grant is not industry specific.

#### To be eligible for the grant a business must:

- have a valid and active ABN (Australian Business Number) and be registered for the GST.
- have an Australia-wide payroll of less than \$10 million in the 2019-20 or 2020-21 financial year.
- employ people in South Australia.
- be the organiser/operator of an event scheduled over the period from 27 December 2021 and 31 March 2022, which was required to be cancelled/postponed.
- the event was a one-off event with an approved COVID Management Plan or COVID Safe Plan catering for an event of over 1,000 combined capacity in one or across multiple locations.
- entities with an on-going COVID-19 Management/Safe Plan for regularly scheduled events are not eligible.
- have incurred a non-recoverable financial loss as a result of the cancellation or postponement of the event.

To receive the full \$25,000 grant, organisers must have experienced a non-recoverable loss that was greater than \$25,000.

#### Arts Sustainability Fund

The Arts Sustainability Fund supports the arts and entertainment sector to continue its activities by providing necessary finance to plan a pathway for recovery from the effects of COVID-19. Funding will support employment and contribute to rebuilding Australia's economy, as well as enhancing community wellbeing and access to cultural experiences across Australia.

The Arts Sustainability Fund will provide \$50 million over two years in 2020–22 so that significant Commonwealth-funded performing arts and culture organisations remain solvent, provide employment, and deliver high-quality cultural and creative activities and experiences for audiences.

Applications close 31 May 2022 or until all funds are allocated, whichever is sooner.

#### SA Heritage Conservation Grants Program - Round 5

If you own a State Heritage Place or a place within a State Heritage Area and are planning a conservation project that will help to conserve or protect significant fabric or heritage values, you may be eligible to receive a Heritage Conservation Grant.

Funding is provided on a dollar-for-dollar basis and is available for private owners, companies, local councils & community groups who are owners of State Heritage Places, and owners or businesses within a State Heritage Area. State Heritage Places owned by the State Government are not eligible.

#### AgTech adoption rebate for livestock producers

As part of the Government of South Australia's \$7.5 million Red Meat and Wool Growth Program, the Livestock Agtech Adoption Rebate will provide livestock producers with a rebate to help adopt technology, enabling productivity and efficiency gains in their enterprises.

#### Amount of funding available:

You can access a rebate of up to \$10,000 (excluding GST) to use towards implementing priorities identified in your Adoption Plan.

#### The rebate can contribute to:

- 75% of costs associated with training, consultancy and/or advisory services up to a total rebate amount of \$2,500 (excluding GST)
- 50% of costs for eligible precision livestock management technology up to a total rebate amount of \$7,500 (excluding GST), of which up to \$2,500 (excluding GST) can be used to pay for pregnancy scanning of ewes.

#### **Boosting Apprenticeships**

The Boosting Apprenticeship Commencements wage subsidy supports businesses and group training organisations to take on new apprentices and trainees, to build a pipeline of skilled workers to support sustained economic recovery.

Through the subsidy, any business or group training organisation that engages an Australian Apprentice between **5 October 2020 and 31 March 2022 may be eligible** for a subsidy of 50 per cent of wages paid to a new or recommencing apprentice or trainee for a 12-month period from the date of commencement to a maximum of \$7,000 per quarter. There is no cap on the number of eligible trainees/apprentices.

#### **Horticulture Netting Infrastructure**

\$14.6 million in grants for South Australian horticulture growers to purchase and install protective netting has been made available. You can apply for up to 50% of costs associated with horticulture netting, up to a maximum of \$300,000.

#### Who can apply?

- primary production businesses
- property owners and share farmers
- · lease holders and businesses that operate as a sole trader
- partnership, trust or private company in horticulture.



Applications close 30 June 2023 or when funding has been exhausted, whichever comes first.

- 'The Andamooka' Community Project Award awarded to a community, or group of volunteers, which has undertaken a community project resulting in significant community benefit.
- The Excellence in Volunteer Management Award offered in partnership with Volunteering SA&NT, this award recognises the dedication and commitment of volunteer managers who support and facilitate the engagement of volunteers.
- The Premier's Award for Corporate Social Responsibility this award recognises the strong contribution the business sector makes to our communities such as through philanthropy, partnerships or releasing employees for volunteer service.

#### Who can nominate?

Any member of the public can nominate eligible recipients for these awards. Self-nominations are accepted.

The awards will be presented at a special 'Volunteer Thank You' event on Monday, 13 June 2022, the Queen's Birthday and South Australia's Volunteers Day.

#### **Funding for Community Tree Planting Events**

In 2022, community-based tree planting events will be held across Australia to mark the Jubilee (70 years of service) of Her Majesty, Queen Elizabeth II. Planting Trees for The Queen's Jubilee (the program) will run over 3 years across 2021-22 to 2023-24. The objective of the program is to mark the significant occasion of Her Majesty's Jubilee through community tree planting events across Australia.

Community consultation is a critical element of the program. In consultation with their community, each MP must identify potential applicants and projects in their electorate and invite them to apply for a grant. Invited applications will be assessed against the program's eligibility criteria through a closed non-competitive process.

Funding of up to \$100,000 is available.

#### **Accelerating Commercialisation Grant - Entrepreneurs' Programme**

Accelerating Commercialisation Grant provides small and medium businesses, entrepreneurs and researchers access to expert advice, guidance and funding on how to take your innovation to market.

#### What do you get?

- up to \$500,000 of matched project funding for Research Commercialisation Entities and Eligible Partner Entities
- up to \$1 million of matched project funding for all other eligible applicants
- expert advice and guidance

#### Who is this for?

Australian entrepreneurs, researchers, inventors, start-ups, Research Commercialisation Entities and small and medium enterprises who have a novel product, process or service they want to commercialise.

#### **Wine Tourism and Cellar Door Grant**

The Wine Tourism and Cellar Door Grant program (the program) has been introduced to support producers who add value by encouraging visitors to wine regions. Wine producers will be able to access an annual grant reflective of their eligible physical cellar door sales. Total amount available is \$10,000,000.

To be eligible for the Wine Tourism and Cellar Door Grant applicants must:

- be a wine producer
- be a legal entity registered for GST and with an active ABN
- have owned or leased a physical cellar door in Australia in the relevant financial year, and/or their related entities have owned or leased a physical cellar door in Australia in the relevant financial year
- have a liquor licence valid in the relevant financial year

#### **Country Education Foundation of Australia**

Your local Country Education Foundation (CEF) supports youth in your area through financial grants for education and employment expenses. Our grants contribute towards apprenticeships, traineeships, cadetships, diplomas, certificate level studies, university qualifications or employment.

#### Who is eligible?

CEF grants are based on financial need, not academic success. You will need to demonstrate commitment to achieving your goal. The four essential selection criteria are:

- you have a demonstrated need
- you are aged 16-25 years
- you have attended school in or currently live in the region covered by your local CEF (view list)
- you are able to demonstrate commitment to achieving your goal.

#### Assistance for businesses employing young people – YOUTH JOBS PaTH

Youth Jobs PaTH (Prepare – Trial – Hire) provides funding to trial a young person aged between 17 - 24 to find out if they're the right fit for your business. If the trial is a success and you hire the young person, you may be eligible for further funding. Grant funding available of up to \$10,000 for Australian businesses.

- Prepare: Young people will undertake Employability Skills Training to prepare them for work
- **Trial:** You can trial a young person in an internship for between 4 and 12 weeks and receive a payment of \$1000 (GST inclusive) to help cover the hosting costs. Interns will receive a \$200 fortnightly incentive payment on top of their income support and are covered by insurance, both paid by the Australian Government
- **Hire:** If you hire the eligible young person, you can receive a wage subsidy of up to \$10,000 (GST inclusive)

#### **CSIRO Kick-Start**

The CSIRO Kick-Start provides matched funding for start-ups and small to medium enterprises to help access CSIRO's research expertise and capabilities to help grow your business with commercial potential.

#### What do you get?

Matched funding between \$10,000 and \$50,000.

Funding may be used to cover the costs of undertaking the project, and may include:

- salary and on-costs of researcher(s)
- travel and accommodation (if required)
- administrative/overhead costs
- external facilities access/services/contractor costs
- Funding may not be used for capital works and expenditure or infrastructure costs.

#### **Nature-based Tourism Co-investment Fund**

The South Australian Government is continuing to actively explore new partnerships to expand our range of nature-based tourism offerings to help position South Australia as a world-class eco-tourism destination.

The Nature-based Tourism Co-investment Fund will be open until June 2022 (or until the fund is exhausted). Applicants can seek grants from \$20,000 to \$1 million and are expected to contribute at least half of the total financial costs of their project.

#### <u>Department for Infrastructure and Transport - Boat Launching Facilities</u>

Boat owners who would like improvements made to the facilities they regularly use should approach their local council, which has the expertise to prepare a detailed funding assistance application. An applicant applying for funding to assist with the construction of new boating facilities must commit to the on-going ownership and maintenance of the facility.

Eligible Boating Projects are either the establishment of new or the upgrade of existing facilities and may include a boat ramp, a wharf or pontoons.


The Youngcare Home Support Grant provides up to \$10,000 (\$20,000 in extreme situations) for essential equipment, home modifications and services, and household items and utilities.
